T/A Vince's Crab House & Seafood Restaurant, 2108 Fallston Road, Fallston, Maryland 21047 appeared in connection with a show cause hearing indicating violation of:

(A) Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of the Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01.

The Violation is alleged to have occurred on October 22, 2019.

Subsequent to the Hearing, the Board considered all the Evidence presented. Based upon the statement of facts (i.e. the written report of Board Inspector William Colburn), as well as applicable License Holder testimony, and with further consideration to License Holders' relevant past record (if any), the Board determined the following:

(A) Motion was made by Vice Chair Tilley and seconded by Commissioner Merchant to find License Holder in violation of Board Rule Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01 (sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years) for the alleged violation on October 22 2019. The vote was unanimous. Motion was made by Vice Chair Tilley and seconded by Commissioner Merchant to impose a fine of \$500.00; the vote was unanimous.

## 2) Old Line Pub, L.L.C. T/A J'Ville Grille

Daniel P. Santoro, Member, Old Line Pub, L.L.C. T/A J'Ville Grille, 3701 Federal Hill Road, Jarrettsville, MD 21084, appeared in connection with a show cause hearing indicating violation of:

(A) Sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years in violation of the Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01.

The Violation is alleged to have occurred on October 22, 2019.

Subsequent to the Hearing, the Board considered all the Evidence presented. Based upon the statement of facts (i.e. the written report of Board Inspector William Colburn), as well as applicable License Holder testimony, and with further consideration to License Holders' relevant past record (if any), the Board determined the following:

(A) Motion was made by Vice Chair Tilley and seconded by Commissioner Merchant to find License Holder in violation of Alcoholic Beverage Article (AB) § 6-304 of the Annotated Code of Maryland ("Code") and Board Rule 4:01 (sale and/or provision of alcoholic beverages to an individual under the legal drinking age of twenty-one (21) years) for the alleged violation on October 22 2019. The vote was unanimous. Motion was made by Vice Chair Tilley and seconded by Commissioner Merchant to impose a fine of \$500.00; the vote was unanimous.

## 3) Neo Festival, L.L.C. T/A Neo Pizza

Leho Poldmaei, Neo Festival, L.L.C. T/A Neo Pizza, 5 Bel Air South Parkway, Suite 1575, Bel Air, Maryland 21015, appeared in connection with a show cause hearing indicating violation of:

(A) Failure to have a supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold, in violation of AB § 22-1903 and Board Rule 3:14.

Based upon the statement of facts (i.e. the written report of Board Inspector William Colburn), as well as applicable License Holder testimony, and with further consideration to License Holders' relevant past record (if any), the Board determined the following:

Motion was made by Commissioner Welch and seconded by Commissioner Majewski to find license holder **in violation** of AB § 22-1903 and Board Rule 3:14 (failure to have a supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold) for the violation on October 1, 2019; the vote was unanimous. Motion was made by Commissioner Welch and seconded by Commissioner Majewski to **impose a fine of** \$250.00; the vote was unanimous.

# 4) P.J.C., Inc. T/A Ice House Liquors

- (A) Motion was made by Commissioner Majewski and seconded by Vice Chair Tilley to find license holders not in violation of Board Rule 3:07 (failure to maintain the above-referenced licensed business premises ("Licensed Premises") in a clean and sanitary manner); the vote was unanimous.
- (B) Motion was made by Commissioner Majewski and seconded by Vice Chair Tilley to find license holders in violation of Board Rule 3:09 (failure to maintain restroom separate and apart from rooms where food and drink are stored); the vote was unanimous. Motion was made by Vice Chair Tilley and seconded by Commissioner Merchant to impose a fine of \$250.00; the vote was unanimous.
- (C) Motion was made by Commissioner Majewski and seconded by Vice Chair Tilley to find license holders not in violation of Board Rule 3:06 (failure to maintain employee records); the vote was unanimous.
- (D) Motion was made by Commissioner Majewski and seconded by Commissioner Merchant to find license holders not in violation of Board Rule 3:02 (failure to cooperate with a representative of the Board).
