2) Aberdeen Rose, Inc., T/A Applebee's Neighborhood Grill & Bar – Change of Officers Transfer Rodger Grim, Sr., Assistant Secretary, Aberdeen Rose, Inc. T/A Applebee's Neighborhood Grill & Bar, 991 Beards Hill Road, Aberdeen, MD, were present along with their attorney, Joseph F. Snee, Jr., in connection with a Supplemental Application for this Class BNR-BWL-On Sale Only License. The purpose of the Application is to remove Cheri Smidt-Wehage and replace her with Rodger Grim, Sr., who will serve as the Responsible Operator. Motion was made and duly seconded to approve this application; the vote was unanimous.

3) Keshar Bhavani Corporation, T/A 7-11 Convenience Store – Show Cause Hearing

Asha Patel, President, Keshar Bhavani Corporation, 504 Edgewood Road, Edgewood, MD appeared along with their attorney Joseph F. Snee, Jr., in connection with a show cause hearing indicating violation of:

a) Failure to have a licensee or designated supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold, in violation of AB, § 22-1903 and Board Rule 3:14;

b) Failure of a license holder to keep on the licensed premises records containing the legal names, aliases, address, date of birth, and a legible photocopy of a government-issued identification of employee Milan "Mike" Patel, in violation of Board Rule 3:06 (g); and

c) Failure of a license holder to keep on the licensed premises records containing the legal names, aliases, address, date of birth, and a legible photocopy of a government-issued identification of employee Gunvant "Geri" Patel, in violation of Board Rule 3:06 (g).

Subsequent to the Hearing, the Board considered all the evidence presented. Based upon the statement of facts (<u>i.e.</u> the written report of Board Inspector William Colburn), as well as applicable License Holder testimony, and with further consideration to License Holder relevant past record (if any), the Board determined the following:

Motion was made and duly seconded to find License Holder in violation of the Alcoholic Beverage Article (AB) § 22-1903 and of the Annotated Code of Maryland ("Code") and Board Rule 3:14 (Failure to have a licensee or designated supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold); the vote was unanimous.

Motion was made and duly seconded to find License Holder in violation of Board Rule 3:06(g) (Failure of a license holder to keep on the licensed premises records containing the legal names, aliases, address, date of birth, and a legible photocopy of a government-issued identification of employee Milan "Mike" Patel); the vote was unanimous.

Motion was made and duly seconded to find License Holder in violation of Board Rule 3:06(g) (Failure of a license holder to keep on the licensed premises records containing the legal names, aliases, address, date of birth, and a legible photocopy of a government-issued identification of employee Gunvant "Geri" Patel); the vote was unanimous.

Motion was made and duly seconded to impose a fine of \$500.00 for License Holder's failure to have a licensee or designated supervisor certified by a state-approved alcohol awareness program on the licensed premises during the hours in which alcoholic beverages may be sold, in violation of AB, § 22-1903 and Board Rule 3:14; the vote was unanimous.

Motion was made and duly seconded to impose a fine of \$250.00 for License Holder's failure to keep on the licensed premises records containing the legal names, aliases, address, date of birth, and a legible photocopy of a government-issued identification of employee Milan "Mike" Patel, in violation of Board Rule 3:06 (g); the vote was unanimous.

Motion was made and duly seconded to impose a fine of \$250.00 for License Holder's failure to keep on the licensed premises records containing the legal names, aliases, address, date of birth, and a legible photocopy of a government-issued identification of employee Gunvant "Geri" Patel, in violation of Board Rule 3:06 (g); the vote was unanimous.
