BOARD MEETING MINUTES
April 5, 2023

CALL MEETING TO ORDER

A regular meeting of the Liquor Control Board for Harford County was called to order at 9:00 a.m. by Chair Majewski at the Board's office. In attendance were Vice Chair Burdette, Commissioner Goddard, new Commissioners Sines and Walters along with Board Counsel Amy K. Finneran and W. Michael Crabbs, General Manager.

INTRODUCTION OF NEW COMMISSIONERS

Chair Majewski introduced newly appointed Commissioners Steven E. Sines and James M. Walters who were sworn in prior to the meeting by Michelle Karczeski, Clerk of the Circuit Court for Harford County.

MINUTES

Vice Chair Burdette made a motion to approve the minutes for March 22, 2023; there was no second and the motion failed. Vice Chair Burdette made a motion to approve the minutes for March 29, 2023; Commissioner Goddard seconded the motion, and the vote was unanimous.

1) Chips & Salsa, L.L.C. T/A Abingdon Grill - Outside Event Application

Dariush Vedadi, Member, Chips & Salsa, L.L.C. T/A Abingdon Grill, 418 Constant Friendship Boulevard, Abingdon, appeared in proper person along with Steven Horant in connection with an Outside Event Application that license holder has submitted for classic car shows that are scheduled for Friday evenings beginning April 14 and ending October 27 for a total of 29 dates. Commissioner Goddard made a motion to approve the Outside Event Application for April 14, 21, and 28 with the understanding that license holder may appear before the Board to request approval of the remaining dates; motion was seconded by Commissioner Walters and the vote was unanimous.

ADMINISTRATIVE BUSINESS

1) The Island at Flying Point Marina, L.L.C. T/A The Island at Flying Point – Season Opening

The Island at Flying Point Marina, L.L.C. T/A The Island at Flying Point, 324 Flying Point Road, Edgewood, has submitted written notice that they intend to open for the summer season on May 6. Vice Chair Burdette made a motion to approve the season opening on May 6; the motion was seconded by Commissioner Sines and the vote was unanimous.

2) Performance Budget for March

The performance budget for March was distributed for review and discussion.

PER DIEM BEER, WINE & LIQUOR LICENSES

1) Bel Air Downtown Alliance – First Fridays – May 5, June 2, July 7, August 4, September 1, October 6

Application submitted by Shelby Tittle and Emma Knight on behalf of Bel Air Downtown Alliance in connection with the First Friday events scheduled for May 5, June 2, July 7, August 4, September 1, and October 6 and held on the County “tire lot” at Churchville Road and Main Street, and also Courtland Street. Commissioner Goddard disclosed that one of his companies sponsors one of the events and this will not affect his vote. Motion was made by Vice Chair Burdette and seconded by Commissioner Sines to approve the application; the vote was unanimous.

RENEWALS TO BE APPROVED

Twenty-six renewals were presented for approval (report attached). Motion was made by Commissioner Goddard and seconded by Commissioner Sines to approve the 26 renewal applications; the vote was unanimous.

STAFF REPORT / PUBLIC COMMENT / BOARD COMMENT

Mrs. Baxter, staff accountant retrieved the check for payment of Mrs. Finneran’s legal fees as there was no second to the prior motion to pay the bills. Mrs. Finneran suggested that the Board adopt a policy for payment of the bills. Mrs. Powell advised that the auditor uses meeting minutes to confirm what bills have been paid as a check and balance as well as confirming that the fines that the Board issues are collected and then reported back to the Board again as a check and balance. There was discussion concerning prior misappropriation of funds.

Motion was made by Commissioner Sines to pay the accounts payable listed above; Commissioner Goddard seconded the motion, and the vote was unanimous.

Mrs. Baxter advised that new signature cards from Harford Bank will be arriving for each Board member’s signature.

General Manager Crabbs reported that a policy and procedure manual and standard operating procedures will be created.

Commissioner Walters made a motion to nominate Commissioner Goddard as Chair; Commissioner Sines seconded the motion. Mrs. Finneran addressed that this vote was taken a few weeks ago and made a presentation concerning the legal and historical aspects of the vote.

Mr. Sines read his statement concerning his appointment to the Board.

Commissioner Goddard made remarks concerning misappropriation, powers of the Chair, funding the County and municipalities, the forensic audit and transparency, and conflict of interest, and discussion was held.

Chair Majewski requested that the Board members meet with staff and legal counsel before continuing a vote for a new Chair.

Motion was made by Commissioner Walters to nominate Commissioner Goddard as Chair; Chair Majewski ruled that the motion is out of order and is not on the agenda; discussion ensued. Commissioner Goddard casted his vote in favor of him being Chair, Commissioner Sines cast the second vote for Commissioner Goddard being Chair, Commissioner Walters was the third vote in favor of Commissioner Goddard, Chair Majewski stated that he was going to not vote as he has ruled the motion out of order, Vice Chair Burdette voted not in favor of Commissioner Goddard as Chair; Commissioner Goddard stated that the vote was 3 to 1 with Chair Majewski abstaining as the motion was out of order as the annual elections vote had previously taken place.

Commissioner Goddard moved to adjourn the meeting and the motion was seconded by Vice Chair Burdette; the vote was unanimous.
