LIVE SCAN PROCEDURE

All persons applying for new and/or transfer of alcoholic beverage licenses must submit Live Scan fingerprints as part of the application process. These fingerprints are then used through CJIS to check the criminal history records of the FBI and the State of Maryland.

- As of 5/1/2022, Live Scan pre-registration applications will no longer be distributed electronically. Due to changes in documentation required by the FBI, these applications **must** be obtained directly from the Liquor Control Board Office.
- An FBI Privacy Act Statement (dated 2018) and a NonCriminal Justice Applicant's Privacy Rights Statement (dated 2019) are attached to this information page. The Board is required to obtain signed copies of these statements for each license applicant and retain them for audit purposes.
- Live scan services are available at various MVA locations, or at one of the private providers found here: https://www.dpscs.state.md.us/publicservs/fingerprint.shtml (scroll down the page to find the section titled "Private Providers").
- Procedures for obtaining a change, correction, or update of an FBI criminal history check are set forth at 28 CFR §16.34. Information regarding this process may be found at: https://www.fbi.gov/services/cjis/identity-history-summary-checks and https://www.edo.cjis.gov. Applicants will be afforded reasonable time to correct, complete, or update a record (if they so choose) before a final fitness determination is made.
