Motion was made by Commissioner Walters and was seconded to approve the application; the vote was unanimous. A license dated July 12, 2024, was prepared and signed by Chair Goddard.

7) Sweet Union, L.L.C., T/A Water Street Seafood - Change in Class Transfer

Theresa Ray, Member, Sweet Union, L.L.C., T/A Water Street Seafood, 654 Water Street, Havre de Grace, appeared in connection with a Change in Class Transfer Application for this Class B1-BW-On Sale Only License that was issued on 01/28/2021. License holder is requesting a change in class to B-BWL-On Sale Only License. Reports submitted by Theresa Ray indicate the food sales were 89% for the past six months. Motion was made by Commissioner Miller and was seconded to approve the application; the vote was unanimous. A license dated July 12, 2024, was prepared and signed by Chair Goddard.

1) Mexican Food III, Inc. T/A Echo Frezco

David Carillo, President, Gabrilla Villagomez, Secretary, Mexican Food III, Inc. T/A Echo Frezco, 1517 Rock Spring Road, Forest Hill, appeared along with manager Pascual Castellanos in connection with violation of the following:

1) CHARGE 1: Failure to comply with Alcohol Awareness certification requirement. AB 4-505(f); AB 22-1903 and Board Rule 3:14 (a) and (c)

The alleged violation occurred on February 6, 2024.

Subsequent to the hearing, the Board considered all the evidence presented. Based upon the statement of facts (i.e., the written report of Inspector Lance Griffin), as well as applicable License Holder's testimony and with further consideration to License Holder's relevant past record (if any), the Board made the following findings:

On Charge 1, motion was made by Vice Chair Majewski and was seconded to find License Holder in violation; the vote was unanimous. Motion was made by Commissioner Walters and was seconded to impose a fine of \$250.00; the vote was unanimous.

2) Shambhavi, Inc. T/A Old School Tavern

Shweta Srivastava, President/Secretary/Treasurer, Shambhavi, Inc. T/A Old School Tavern, 3403 Conowingo Road Street, appeared along with her attorney Carolyn M. Evans in connection with violation of the following:

Based upon the statement of facts (i.e., the written report of Chief Inspector Buchler), as well as applicable License Holder's testimony and with further consideration to License Holder's relevant past record (if any), motion was made by Commissioner Walters and was seconded to find license holder in violation.
